

## Responsibilities

The Board of Directors is responsible for determining Company Policies. Mark Davison and Dave Elliott, Chief Executives, have been appointed as having overall responsibility for this Policy.

This Privacy Policy describes our policies and procedures for collecting, using, and disclosing your information when you use the Service. It also tells you about your privacy rights and how the law protects you.

We use your personal data to provide and improve the Service. By using the Service, you agree to the collection and use of information following this privacy policy.

**Scope:** This Policy applies to all employees of MGL Group (MGL Demolition, Rainton Construction & Tynedale Roadstone) regardless of employment agreement or position.

#### **Data Protection Officer**

We have appointed a Data Protection Officer (DPO) to oversee compliance with GDPR and other data protection laws. The DPO is responsible for monitoring our data protection strategy and its implementation to ensure compliance with GDPR requirements.

## **Training**

We regularly train employees on data protection and privacy policies. This training ensures all employees understand their responsibilities and the importance of protecting personal data.

## **Interpretation and Definitions**

#### Interpretation

The words of which the initial letter is capitalised have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear singular or plural.

**User-Friendly Language:** We have ensured that the language used in this Privacy Policy is user-friendly and easily understandable by non-legal professionals. Our goal is to make the policy accessible and clear to all users.

#### **Definitions**

- Account: This means a unique account is created for you to access our Service or parts of our Service.
- **Company** (referred to as either "the Company", "We", "Us", or "Our" in this Agreement): Refers to MGL Group Limited, Davison House, Rennys Lane, Dragonville Industrial Estate, Durham, DH1 2RS. For the GDPR, the Company is the Data Controller.
- **Cookies**: These are small files placed on your computer, mobile device, or any other device by a website. They contain details of your browsing history on that website, among other uses.
- Country: Refers to the United Kingdom.
- **Data Controller**: For the GDPR (General Data Protection Regulation), the data controller refers to the Company as the legal person who, alone or jointly with others, determines the purposes and means of processing Personal Data.

- Device: Any device that can access the Service, such as a computer, a mobile phone, or a digital tablet.
- GDPR: Refers to the EU General Data Protection Regulation.
- **Personal Data**: Any information related to an identified or identifiable individual. For GDPR, Personal Data means any information relating to You, such as a name, an identification number, location data, online identifier or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity.
- **Service**: Refers to the Website.
- Service Provider: Means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analysing how the Service is used. For the GDPR, Service Providers are considered Data Processors.

Usage Data may include information such as Your Device's Internet Protocol address (e.g., IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers, and other diagnostic data.

When you access the Service by or through a mobile device, we may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile device's unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers, and other diagnostic data.

# Tracking Technologies and Cookies

Our cookie policy has been enhanced to include detailed information about the types of cookies we use, their purposes, and how users can manage their cookie preferences. This information is available in the Cookies section of our Privacy Policy.

With Your consent: We may disclose Your personal information for any other purpose with Your consent.

#### **Retention of Your Personal Data**

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period, except when it is used to strengthen the security or improve the functionality of Our Service or when we are legally obligated to retain it for more extended periods.

### **Transfer of Your Personal Data**

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your county, country or other governmental jurisdiction where the data protection laws may differ from those from Your jurisdiction.

Your consent to this Privacy Policy, followed by Your submission of such information, represents Your agreement to that transfer.

The Company will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy. No transfer of Your Personal Data will occur to an organisation or a country unless adequate controls exist, including the security of your data and other personal information.

#### **Delete Your Personal Data**

You have the right to delete or request that We assist in deleting the Personal Data that We have collected about You.

Our Service may give You the ability to delete certain information about You from within the Service.

You may update, amend, or delete your information anytime by signing in to Your Account if you have one and visiting the account settings section that allows you to manage your personal information. You may also contact us to request access to, correct, or delete any personal information you provided.

#### **Business Transactions**

- **Vital interests:** Processing Personal Data is necessary to protect Your vital interests or those of another natural person.
- **Public interests:** Processing Personal Data is related to a task that is carried out in the public interest or the exercise of official authority vested in the Company.
- **Legitimate interests:** Processing Personal Data is necessary for the legitimate interests pursued by the Company.

In any case, the Company will gladly help clarify the specific legal basis that applies to the processing, mainly whether the provision of Personal Data is a statutory or contractual requirement or a requirement necessary to enter into a contract.
